The Lee County Board of Supervisors met on Tuesday, March 28, 2017 at 9:00 a.m., at the Newberry Senior Center in Fort Madison.

The Board opened the meeting by reciting the Pledge of Allegiance.

Moved by Pflug, seconded by Folluo, to approve the agenda. Motion carried.

At 9:01 a.m. Larkin opened a Public Hearing for the purpose of renewing a lease agreement with the Newberry Senior Group. Folluo thanked the Senior Group for taking such good care of the Center. Newberry Senior Group President told the Board that the Group has some funds from bingo that can be used for improvements at the Center. RESOLUTION OF THE LEE COUNTY BOARD OF SUPERVISORS

RESOLUTION SETTING PUBLIC HEARING AND PROPOSING THE SALE OF CERTAIN REAL ESTATE RECEIVED BY WAY OF TREASURER'S DEED

WHEREAS, Lee County is eligible to receive a Treasurer's Deed to parcels described below and collectively referred to as 1028 Main Street, Keokuk, Iowa; and

WHEREAS, the Board wishes to hear information regarding the offer and also whether other individuals are interested in purchasing the property and to submit a competing bid.

NOW THEREFORE BE IT RESOLVED, that the Auditor is directed to set the following proposed Resolution for public hearing on the 11th day of April, 2017, at 9:01 o'clock a.m. at the Lee County Sheriff's Office, 2530 255th Street, Montrose:

BE IT RESOLVED that the Lee County Board of Supervisors proposes to sell the following property at 1028 Main Street, Keokuk described as:

The Northwesterly Half (1/2) of Lot Six (6) in Block One Hundred Fifty-Four (154) in the Original City of Keokuk, Lee County, Iowa.

Sealed bids will be accepted at the Lee County Board of Supervisors Office, 933 Avenue H, Fort Madison, Iowa. The successful bidder will receive a Quit Claim Deed signed by the Chairman of the Lee County Board of Supervisors who is authorized to sign such a deed on behalf of the County. Bids must be received no later than 4:30 p.m. on the 10th day of April, 2017. The successful bidder must pay in full within seven (7) days of the acceptance of the bid and pay all recording fees. Failure to make that payment in full will void the bid.

Following the public hearing the Board will determine whether to accept the proposal. If a proposal is accepted the Board will transfer title received by Treasurer's Deed by quit claim deed. The Chairman of the Lee County Board of Supervisors will be authorized to sign the deed on behalf of the Board. A copy of this Resolution, Notice of Public Hearing and Final Resolution of the Board will be duly recorded with the Lee County Recorder's Office. The notice of public hearing should be published in accordance with section 331.305.

If the Board elects to select the current bid or any other cash bidder, that amount of the bid should be on file with the Auditor's Office within thirty (30) days. If the amount is deposited with the Auditor's Office the Board will proceed with closing.

The auditor shall send a copy of this resolution to the current bidder.
